Why?	Financial companies choose how they share your personal information. Consumers have the right to limit some but not all sharing. This notice tells you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.	
What?	The types of personal information we collect and share depend on the product or service you have with us. How?	All financial companies need to share customers' personal information to run their everyday business. Who is providing this notice?	Ningodwaaswi, LLC d/b/a Sky Trail Cash a business entity of the Lac du Flambeau Indian Community, is providing this privacy policy.
What we do:	
How does Sky Trail Cash protect my personal information?	To protect your personal information from unauthorized access and use, we use security measures. These measures include computer safeguards and secured files and buildings.
How does Sky Trail Cash collect my personal information?	We collect your personal information, for example, when you: <ul style="list-style-type: none"> • Apply for a loan; • Give us your income information; • Tell us where to send the money; • Provide account information; • Provide employment information; and • We also collect your personal information from others, such as credit bureaus, affiliates or other companies.
Why can't I limit all sharing?	You have the right to limit only: <ul style="list-style-type: none"> • Sharing for affiliate' everyday business purposes information about your creditworthiness; • Affiliates from using your information to market to you; and • Sharing for nonaffiliates to market to you.
What happens when I limit sharing for an account I hold jointly with someone else?	Your choices will apply to everyone on your account.
Definitions:	
Affiliates	Companies related by common ownership or control. They can be financial and nonfinancial companies. <ul style="list-style-type: none"> • <i>Our affiliates include other business entities of the Lac du Flambeau Indian Community.</i>
Nonaffiliates	Companies not related by common ownership or control. They can be financial and nonfinancial companies. Nonaffiliates we share with include service providers, data processors, and advertisers.
Joint marketing	A formal agreement between nonaffiliated financial companies that together market financial products or services to you. <ul style="list-style-type: none"> • <i>Sky Trail Cash does not jointly market.</i>
